ORDER, JUDGMENT AND INJUNCTION

This matter come before the Court on the Motion of Plaintiff Rio S. Vitale and Plaintiff Ciao St. Louis, pursuant to Rule 90.02 Mo.R.Civ.P., to enjoin Defendant Michael J. Cross and Defendant Italian Community of St. Louis from accusations and statements that Plaintiff Rio S. Vitale is associated with the Mafia or any other criminal enterprise or that Plaintiff Ciao St. Louis is a Mafia or criminal organization. Plaintiffs appear by counsel and present the Court with the verified Petition and a verified statement by Defendant Michael J. Cross that he is aware of no circumstances to support any statement that Rio Vitale is a criminal or that he is associated with the Mafia or any other criminal organization, and that prior statements to that effect are false: Plaintiff Rio S. Vitale is present: Defendant Michael J. Cross

It is therefore ORDERED, ADJUDGED AND DECREED that Defendant Michael J. Cross, Defendant Italian Community of St. Louis, and all others in concert with them, are hereby compelled to directly and indirectly:

A. Remove any postings or statements from any social media or other location to the effect that:

Plaintiff Ciao St. Louis is or was a mafia organization;

Plaintiff Rio S. Vitale is or was a mafia boss;

Plaintiff Rio S. Vitale is or was a mafia associate;

Plaintiff Rio S. Vitale is or was a criminal;

Plaintiff Rio S. Vitale has engaged in criminal acts;

Plaintiff Rio S. Vitale has been convicted of any crime; and/or

That either Plaintiff had been censured by the Italian government and/or its representatives in the United States; and


B. Cease, desist and refrain from any other publication, dissemination or repetition of such statements, orally or in writing.

C. Cease, desist and refrain from any publication, dissemination or other use of any electronic database or list of names and any video, audio or electronic recordings which originated with Plaintiff Ciao St. Louis or which was taken from Plaintiff Ciao St. Louis without its permission.

IT IS FURTHER ORDERED that any violation of this Order will subject Defendant Michael J. Cross and/or Defendant Italian Community of St. Louis to sanctions.

IT IS FURTHER ORDERED that this Oder shall expire 36 months of its entry , unless further extended by the Court.
